4. Membership application

6. President's Report - Zsolt Szabo

At the end of a triennial period I would like to thank "my team", "my ExCo" and especially to Daniel Nagle for all the work, for his personal connections and relations to run legally the Federation!

At the end of a triennial period the final balance is:

- A Federation running legally
 - The last three years has provided confirmation of the decision to base the IFSSH registration in USA and run it in a "tax exempt" status at a relatively low cost.
- A Federation with safe and improving finances
 - Now that we are functioning legally and working within this which means a need for finances to cover e.g. legal expenses, more meetings and new informational background - our financial status is safe and growing.
- A Federation with the main goal to help and support

- The main activity of the Federation is the CES activity. Financial support provided for different educational activities, teaching and learning purposes is continuously increasing.
- A Federation with friends all around the World
 - We have improved our relationship with FESSH (two congresses in Europe), and the ASSH (bid for an IFSSH congress). We look for partners based on friendship and science, not politics.
- A Federation with its first "combined" congress
 - We were able to agree and make compromises to organise a triennial combined congress where the priorities of both Federations have been respected.
- A Federation with the highest congress attendance
 - Thanks to the German organizers and the bilateral support of IFSSH and FESSH, this 2019 Congress has the highest attendance and scientific participation at a hand surgery event.

What could/should be done differently?

- Active participation of the delegates
 - The value of the IFSSH is given by the value of the delegates we need full, enthusiastic participation.
- Higher interest for "quality" financial support
 - The CES prefers member society requests over personal requests.
 Educational events promoting hand surgery in economically disadvantaged parts of the World are highly encouraged.
- Involvement of young hand surgeons
 - The IFSSH should not be a Club of old rich gentlemen. Younger surgeons
 must be encouraged to participate and take active roles. Fellowships,
 grants, support and prizes dedicated to the young generation should be
 considered, as should representation of young colleagues within the ExCo.
- Financially affordable congresses
 - Science should be affordable for everybody independent of their financial status. Low budget congress events are to be considered for inclusion. An option to reduce overall congress rates may be to separate the scientific and social components.
- Scientific committees
 - The existing structure described in the Bylaws may not be needed.
 Alternatives may be considered to find new tasks and produce valuable educational content through modified or new activities.
- Pioneers in hand surgery
 - What is a "valuable" contribution? Who is a valuable contributor? The ExCo must maintain the description that a Pioneer has contributed

exceptionally to hand surgery and request that nominating societies only submit candidates of the highest calibre.

- Improving transparency
 - All decisions and processes are done by the ExCo and/or Delegates'
 Council on behalf of the IFSSH member societies. Transparency is required
 in the selection of IFSSH officers and in all processes of decision making.

Tasks for consideration in the (near) future:

- Changing the structure of the ExCo
- Changing the administration of IFSSH
- Changing the Bylaws
- Changing the frequency of our congresses

Change should not be done only for the pleasure of changing! Change should not be done in order to satisfy somebody's personal ambitions! Change should serve a better function!

The IFSSH exists and acts for the benefit of Hand Surgery.

7. Secretary-General's Finance Report - Daniel Nagle

The IFSSH treasury is financially sound. At April 30th 2019 the balance was US\$1,154,602.37. Approximately \$300,000 of this is kept with Wells Fargo as operating funds. The remainder is invested via Fidelity with the portfolio managed by Chris Crenshaw (North Carolina, USA).

Income (comprised mainly of dues payments) continues to be at a similar level to the operating expenses and educational grant payments. In 2018 \$200,000 was moved from the bank account to the investment account, which is conservatively invested. The intent is to build the corpus and support an increased number of educational grants (or a similar number to a higher level) with any additional gains.

The IFSSH is up to date with legal obligations. The Not-for-Profit status is maintained by Chicago Law Partners (Illinois, USA) and accounting obligations are undertaken with the assistance of Mann Weitz & Associates LLC (Illinois, USA).

8. Committee for Educational Sponsorship Report - Marc Garcia-Elias

The CES has awarded US \$48,000 for projects undertaken in 2018/19:

- Hand Surgery Fellowship assistance Dr Mohamed Abdelrahman, from Khartoum, Sudan - US \$10,900 - Dr Abdelrahman travelled to Shandong Hospital, China, for a six month Hand & Microsurgery Fellowship. As Sudan is not a member society, this was granted by the CES with the recommendation of the Association of the Chinese-Speaking Hand Surgeons United.
- Esser Masterclass Dr Michael Zuidam, Netherlands US \$10,000 The Esser group in Rotterdam organised courses and placed CES money specifically towards supporting registrants from developing countries. The first recipient was Dr Mohamed Abdelrahman. This programme is planned to continue.
- International Consortium for Health Outcomes Measurement (ICHOM) Adult Hand Set Dr Steven Hovius. US \$10,000 ICHOM received funding from a number of groups and continues to work on the development of an outcome set for adult hand conditions.
- 2nd International Symposium on Surgery of the Spastic Upper Limb, Venice Dr Caroline Leclercq US \$7,500 The CES considered that the specific subject matter, the training provided to surgeons from many countries and of varying levels of expertise, and the ease of travel for all to get to Venice for the conference as worthwhile reasons to support this symposium. The CES grant was used to support registrations for surgeons from developing countries.
- IFSHT (IFSSH/IFSHT Triennial Travel Grant; Evelyn Mackin Triennial Award; IFSHT/IFSSH International Teaching Grant) \$9600 The IFSHT continue to use CES support for its intended use. Multiple recipients benefit from a wide geographic basis.

All recipients have provided reports. These will be placed on the website and in the ezine.

One application has recently been received from the organisers of the 2020 Asian-Pacific Federation of Societies for Surgery of the Hand (APFSSH) Congress. This request is for funding to allow a number of surgeons from developing countries to attend the conference at reduced or gratis registration rates. This application is under review.

Marc Garcia-Elias reported that a future aim of Committee for Educational Sponsorship is to have the means to foster the education of surgeons outside of the IFSSH member societies. A number of options are being considered to allow this to happen and this will be addressed in the next review of the IFSSH bylaws.

Marc Garcia-Elias thanked the members of the Committee for Educational Sponsorship, Goo Hyun Baek and Raja Sabapathy, for their assistance in assessing each application throughout the term.





All delegates were requested to check if their society had contributed an updated history (https://ifssh.info/member nation-histories.php) and, if not, to forward to the IFSSH secretariat/Historian. This is a new component of the website and histories will also be shared via the ezine.

The Twitter account is also regularly updated and can be found via @IFSSHand.

10. Newsletter / Ezine - Daniel Nagle

The newsletter is produced by the Secretary-General four times per year. This is published in print in the JHS(Am), JHS(AP) and ezine. The JHS(Eu) place it on their website following discussions led by David Shewring and the publishers.

Ulrich Mennen continues to produce the quarterly ezine with the assistance of a layout publisher in South Africa. There is a subscriber database of approximately 5000 individuals In addition, each society delegate is requested to pass on the ezine to all individuals within their society.

11. 2019-2022 Executive Committee - Michael Tonkin

The 2016-2019 Executive Committee finishes its term at this meeting. Michael Tonkin described that an efficient and effective committee requires a combination of experience, youth, skills, knowledge, and geography. The Delegates' Council are entrusted with the responsibility to elect those who represent the IFSSH at Executive Committee level.

The establishment of the incoming Executive Committee involves some automatic progressions and some elections. Those positions that involve elections will be determined with the assistance of an electronic voting system. This system is anonymous. Votes are registered to the main receiving computer, but only with the answer (i.e. the total number of submitted votes is visible to allow confirmation that all have successfully voted, but the results and all reports exclude the submitting society's details). Each delegate and ExCo member receives one vote. The system will not register multiple votes from each device. One proxy has been received. Six societies are ineligible to vote because of outstanding financial commitments; these society delegates will not receive a voting device.

Candidates will be listed alphabetically. A majority must be confirmed i.e. if a circumstance of three nominees and one person receives more than 50% of the votes

then they are immediately selected. However, if no-one receives >50% of the vote, a subsequent vote will be undertaken between only the two highest ranking nominees

from the initial vote.

The voting devices were distributed and test scenarios undertaken until 100%

compliance was achieved.

Michael Tonkin introduced the first two members of the 2019-2022 term, moving via

automatic progression to their new roles:

President: Marc Garcia-Elias

Voting was conducted for the President Elect position. Nominees: Daniel Nagle and

Eduardo Zancolli. The majority vote elected Daniel Nagle.

The Secretary General Elect moves to Secretary-General via automatic progression.

Secretary-General: Goo Hyun Baek

Voting was conducted for the Secretary-General Elect position. Nominees: Raja Sabapathy, Jin Bo Tang and David Warwick. A majority was reached within the initial

voting round for Raja Sabapathy.

Secretary-General Elect: Raja Sabapathy

The Bylaws state that the Historian position may be performed for two consecutive terms. David Warwick, the current Historian, has indicated he will undertake the second

term.

Voting was conducted for the Member-at-Large position. Nominees: Ryosuke Kakinoki

and Jin Bo Tang. The majority vote elected Jin Bo Tang.

Member-at-Large: Jin Bo Tang

Michael Tonkin welcomed the new Executive Committee.

Zsolt Szabo thanked Michael Tonkin, the outgoing Immediate Past President, for his

service to the IFSSH and noted his contributions since joining the ExCo in 2004.

12. 14th IFSSH Congress - Berlin, 2019 - Jörg van Schoonhoven / Max Haerle

The 2019 IFSSH & IFSHT Congress attracted more interest than anticipated. 1800 abstracts were received and over 3950 registrations have been processed (560 from Germany, 222 UK, 219 Switzerland, 203 Netherlands and >100 from USA, Japan, Brazil, Australia and Austria). Participants come from 92 countries. The congress rooms have been busy for all sessions and the social events have been well-attended. The local committee are pleased with the outcome and honoured to have hosted the congress.

Zsolt Szabo thanked the local committee for their congress organisation and hospitality.

13. 15th IFSSH Congress - London, 2022 - Jonathan Hobby

The London IFSSH Triennial Congress will be held from 27th June to 1st July 2022. London is easily accessible from all continents and the local organising committee hope for a high level of international participation.

The Queen Elizabeth II centre (Westminster) has been booked as the congress venue. The central London location is convenient for hotels, with plenty within walking distance or a straightforward commute from cheaper hotels. There are many museums, theatres and attractions nearby.

The BSSH and its IFSSH organising committee are working closely with FESSH to determine the optimal arrangements for an IFSSH Congress that provides facilities for FESSH as needed. The local organising committee will also benefit from the experience of the current German committee. The congress is a combined with the therapists.

An instructional course is planned, most likely with a similar Educational Day as undertaken in Berlin.

Scientific committees will be planning sessions in the near future and be enlisting international members to assist.

14. 16th IFSSH Congress, 2025 - host selection

The 2025 Congress is to be held in The Americas according to the IFSSH Congress rotation schedule. Three bids have been received from member societies wishing to host this congress:

- American Society for Surgery of the Hand and American Association for Hand Surgery (combined with American Society of Hand Therapists)

- Brazilian Society for Surgery of the Hand (combined with Brazilian Society of Hand Therapists)
- Colombian Association for Hand Surgery (combined with Colombian Association for Hand Therapy)

Daniel Nagle recognised the work placed into the bid documents and thanked each society for their efforts. As per the congress host guidelines, each bid was distributed to the ExCo, delegates and IFSHT at least 3 months prior to this council meeting.

He invited each society to deliver a 6 minute presentation, to be followed by a vote from the Delegates' Council.

 a. American Society for Surgery of the Hand and American Association for Hand Surgery (combined with American Society of Hand Therapists)
 Presentation delivered by Scott Levin (ASSH President).

As throughout history, the US is interested in welcoming all from abroad. Washington D.C. is the proposed congress city, with the meeting at the Marriott Wardman Park. This is a geographically accessible city, easy to navigate and family friendly. There are activities for all - scientific and medical interests, libraries and museums, a wide variety of food options, clean and efficient transport, and multilingual signage. The congress would be organised under the combined efforts of the AAHS, ASSH and ASHT - each group has experience in organising large scale meetings and links to industry support. A host programme would be incorporated to encourage maximum attendance.

 Brazilian Society for Surgery of the Hand (combined with Brazilian Society of Hand Therapists)

Presentation delivered by Marcello Rosa de Resinda (SBCM President).

The SBCM has a long history, founded in 1955 it is the third oldest hand society in the world. It has a proud history of well-known society Presidents, including four that went on to be Presidents of the South American Federation and one IFSSH President. The society holds a large annual congress with good industry support. Its scientific sessions includes Evidence based medicine, advances in hand surgery, and new frontiers in medical technology. Rio de Janeiro has been chosen as the proposed site as it has a proven track record with large scale events, including recently hosting 12,000 participants at the World Gynaecology Congress. The city has sufficient infrastructure alongside opportunities for tourism. The suggested congress centre is the Windsor Complex venue which includes three hotels and has exhibition capacity for 7000 people. The local organising committee suggest a number of registration rates to allow for discounts for trainees and those from developing nations. Brazil can be accessed easily from Europe, Africa, Asia-Pacific and the Americas and entry requirements are visa-free for a large number of countries.

c. Colombian Association for Hand Surgery (combined with Colombian Association for Hand Therapy)

Presentation delivered by Luis Naquira (ASOCIMANO President).

ASOCIMANO is a very active society at local, national and international level. At this Berlin congress 28 papers will be presented by Colombian members and the next JHSE issue will also include their contributions. The 2025 Congress site is proposed to be Cartagena de Indias, a UNESCO World Heritage site. The city is an outdoor museum to walk around, accessible by 12 direct international flights with the airport only 10 minutes from the city. Entry to Colombia is visa-free for over 85 countries. A stay in Cartagena de Indias is compatible with all budgets. A new congress venue is under construction (due to open in 2020) and is also within walking distance. Tourism and culture are readily available locally and nationally.

Via the electronic voting system, the ExCo and Delegates' Council registered their votes. The USA combined bid was successful.

15. IFSSH Pioneers - Michael Tonkin

At this 2019 Congress, 37 Pioneers from 19 societies were honoured. The recognition of these surgeons as those who have served and contributed internationally to hand surgery is one of the most important aspects of the triennial congress.

Nominating societies should continue to observe the significance of this honour by only recommending those who fulfil the criteria. This will retain the importance of the award.

16. IFSSH Scientific Committees - Daniel Nagle

The Scientific Committees are a component of the IFSSH Bylaws. The IFSSH Executive have been discussing a number of ways to maintain these committees and make their activities relevant to the aims of the IFSSH, whilst also ensuring the committee participants are recognised for their work. For example, reviews and expert opinions may both be valid options for committee reports and publication in the ezine and journals would allow the citation of this work. These discussions will continue and delegates can forward suggestions for optimal committee activities via administration@ifssh.info.

17. Other Business arising from Executive Committee Meeting

The IFSSH Executive will be undertaking a review of the Bylaws. This will cover a number

of aspects such as the roles of the ExCo (e.g. redefine the Historian, include Communications) and the Scientific Committees as detailed above, as well as processes

undertaken throughout the triennium (e.g. election.

This past year has seen many developments in the activities of the APFSSH. Many of the original aims of the first Charter of the APFSSH being to promote Hand Surgery and Education in the Region and to support a Travelling Fellowship have been somewhat hampered by a lack of funds and difficulties in coordinating activities throughout the region under the umbrella of the APFSSH. All the member societies are very active in their own countries and have frequent combined scientific meetings. The Federation has some funds but these are being held by member societies from donations and from the running of our scientific meetings. In order to increase the activity of the Federation the executive has over the past 2 years been working towards establishing an office and a bank account where funds can be collected and then used to achieve the aims of the Federation. With so many differing countries and laws in the region this proved to be a little difficult but with the work of you Singaporean colleagues we are on the threshold of opening an account and having an administrative base in Singapore. In order to satisfy the financial requirements of Singapore it has also been necessary to establish a proper Constitution. This has been a monumental task with contributions from many members of our Federation but has also been very useful in that we not have a proper framework for the efficient running of what has become quite a large organization. The Constitution was voted on and adopted by the executive and member delegates at a Council meeting in Taiwan last month. With a few details to complete over the next few months the Federation will soon be able to achieve its aims in the region.

The Journal of Hand Surgery Asian Pacific Volume, is the official journal of the APFSSH which is published 4 times a year. 181 articles are submitted in 2018, and acceptance rate was 36%.

Federation website is also undergoing a redevelopment and with the increased activity of the Federation we hope to encourage more contributions to the website with meeting announcement and other educational activities.

With the Constitutional work completed the attention of the Federation is now directed towards the next APFSSH meeting to be held in Melbourne Australia in March 2020. This is co-convened by the Australian and New Zealand Hand Surgery Societies and the Asian Pacific Wrist Association. It is again held in conjunction with the APFSHT with many combined sessions. We are also trying to support registrations from hand surgery societies from developing nations in our region by offering reduced registration rates and raising funds from other registrations to further support attendees from these member societies.

Whilst Melbourne may suffer from the tyranny of distance I would encourage as many of you as possible to attend. I am sure we can make the trip worthwhile.

The hand and wrist represent one of the most challenging structures in the study of biomechanics, as well as in the evaluation of many biomechanical principles. Hand and wrist biomechanics has been somewhat under developed in comparison to mainstream biomechanics research over the past century. While numerous biomechanical studies have been initiated by surgeons and engineers, collaborative efforts among scientists and clinicians are required in order for continuing progression in research and further improvement of treatment modalities and outcomes.

For over 25 years, the International Symposia on Hand and Wrist Biomechanics have provided the opportunity for global scientific exchange and mutual encouragement among basic science and clinical investigators. In 2012, the International Advisory Board decided to form Hand and Wrist Biomechanics International (HWBI) to further enhance the development of hand and wrist biomechanics and its clinical applications. It is our hope that through the structured organization of HWBI, research activities related to hand and wrist biomechanics will be elevated and clinical translation will be improved.

HWBI is affiliated with International Federation of Societies for Surgery of the Hand (IFSSH) and the International Society of Biomechanics (ISB). With these affiliations, the HWBI benefits from IFSSH's and ISB's established excellence as premier international organizations and their vast umbrella networks in promoting basic science and clinical applications. In turn, the HWBI contributes its specialty knowledge to the broad fields of hand surgery and biomechanics. HWBI regularly organizes symposia in conjunction with IFSSH and ISB congresses.
